- 1. - **2. MEDICAL ATTENTION**: I hereby give my consent to the Palmetto Lacrosse CHS and its employees to provide medical attention, transportation and emergency medical services as warranted in the course of my child's participation in the Palmetto Lacrosse Camp..
- **3. REFUND POLICY:** Refunds will be at the sole discretion of Palmetto Lacrosse. A written request my be sent via email for consideration. I understand that there is NO REFUND after one (1) week, or there after, prior to the first day of play for cancellation FOR ANY REASON (including illness, injury, family vacation, personal, etc.). In the event of a state-required social distancing restriction, refunds will be issued. Palmetto Lacrosse CHS will not cancel programs due to seasonal, weather-related conditions. Palmetto Lacrosse CHS cannot provide refunds for cancellations or postponements that are weather-related.
- **4. CODE OF CONDUCT**: I agree that I will discuss with my child the importance of following rules for both the safety of my child, as well as others.
